**WorkLink WDB Hires New Executive Director**

*(Clemson, SC – December 1, 2025)* – WorkLink Workforce Development Board has named Victoria Britton to the position of Executive Director. Ms. Britton will serve as chief operating officer of WorkLink, whose mission is to connect companies and employees in Anderson, Oconee, and Pickens Counties. She begins her new role with WorkLink on December 1, 2025.

Ms. Britton assumes the Executive Director position with more than 20 years of workforce development experience, managing federal and state programs, strategic partnerships, and talent pipeline initiatives. Most recently, she served as SCSEP Director for the State of Indiana’s Department of Workforce Development (2023–2025), where she authored the \$10M Indiana State Plan for SCSEP, secured nearly \$500K for a statewide awareness campaign, and led multi-state collaboration efforts.

Her career also includes serving as Workforce Development Manager at CEDIA (2018–2020), where she led global campaigns to address skilled labor shortages, advocated for occupational code updates, and managed national training programs. Earlier, Ms. Britton spent over a decade as a Manager within the Marion County WorkOne System (2005–2018), directing workforce teams, developing SOPs, training staff, and building employer partnerships.

Ms. Britton holds a Bachelor’s degree in Fine/Studio Arts from Indiana University Indianapolis and a Master of Fine Arts, Magna Cum Laude, from the Maryland Institute College of Art. She is also a Global Career Development Facilitator (GCDF) and has been recognized with multiple state-level awards for workforce service excellence.

Now residing in Anderson County, South Carolina, Ms. Britton looks forward to engaging with the local community as she steps into this leadership role. WorkLink extends a warm welcome to Ms. Britton and looks forward to her leadership in advancing workforce development across the region.
